Regarding Reservation of seats in Higher Educational Institutes of Assam

Sir,

In inviting a reference to the subject cited above, I am to directed to inform you that Govt. of Assam in Higher Education Department has issued Notification vide Ecf No.328482/7 dated 20.07.2023 regarding Reservation of Seats in Higher Educational Institutes as per Cabinet decision taken on 12/07/2023.

As regards to the Notification referred to above, this Department seek to issue the following clarification :

- 1) The categorisation of creamy/non-creamy layer has to be maintained as per rule in respect of OBC candidates.
- 2) The Reservation of seats for candidates belonging to Ahom, Chutia, Moran, Matak, Koch Rajbongshi and Tea Tribe community will be within 27% of OBC reservation.
- 3) The Notification issued by this department vide Ecf No.328482/7 dated 20.07.23 shall be applicable from the current academic session, 2023-24. If any University has completed the admission process, then those Universities need to ensure admission as per this notification, and if required, may increase the seat number.

This is for favor of your kind information and necessary action.
